- 3. The Bid should be submitted online in *www. tendersodisha.gov.in* furnishing with scan copies of valid Registration Certificate, GSTIN Registration Certificate, ITCC, PAN card, Affidavit about the authenticity of the tender documents and No relation Certificate etc. on "on line" are mandatory along with the tender documents, otherwise his / her bid shall be declared as non-responsive and thus liable for rejection. - 4. Additional performance security shall be obtained from the bidder, when the Tender amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional performance security(APS). APS along with ISD @2% of BID amount shall be deposited in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Joint Director, Survey & Planning, Bhubaneswar, Odisha within seven days from the date of finalization of tender otherwisethe bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.
- 5. The single tender received in the 1st tender call shall be cancelled without opening of the bid. The acceptance of a single tender received even after re-tendering should have prior approval of next higher authority. In case of cancellation of single Tender which have not been evaluated, the Tender Paper cost deposited by the concerned Bidder shall be refunded to him/her as per office memorandum No. 12925/W, dtd. 23.08.2018 of Works Dept. - 6. If the rate quoted by the bidder is less than 15% of the tender amount then such a bid shall be rejected and the tender shall be finalized basing on the merit of rest bids. But if more than one bid is quoted at same percentage of rate i.e. up to 14.99% (Decimal up to two nos. will be taken for all practical purpose without rounding up) less than the estimated cost the tender inviting authority will finalize the tender through a transparent lottery system. The transparent lottery will be held in the office of the Joint Director, Survey & Planning, Satyanagar, Bhubaneswar-7, Odisha and the date and time of transparent lottery will be intimated later if required.

- 7. Validity of tender shall be a period of **90** (**Ninety**) days from the last date of receipt of bids. If any bidder / tenderer withdraw his bid / tender before the said period or make any modification in terms and conditions of the bid, the E.M.D deposited at the time of submission of the tender shall stands forfeited.
