Instruction to the applicants for RWHC

- 1. The applicants desirous of implementing "CHHATA" are to download the **form "B"** from the **DOWR Odisha portal** https://dowr.odisha.gov.in/projects-%26-schemes/schemes/ground-water-development
- 2. Necessary documents are to be mandatorily attached with the application. In no case undertaking for submission of required documents at a later date than the date of application will be entertained.
- 3. No documents other than required will be allowed.
- 4. The applicants are advised to go through the list of 27 towns where CHHATA scheme is to be implemented.
- 5. There will be no application fee for applying empanelment of RWHC..
- 6. The completed application in Form "B" is needed to be submitted to the GWD Directorate at Bhubaneswar by registered post/speed post before the last date as per advertisement published.
- 7. The application for RWHC will be scrutinised on the basis of eligibility in regard to educational qualification, which is mandatory. Experience in RRHS supervision is optional.
- 8. The shortlisted applicants will be required to undergo a 2 weeks training on Roof Top Rain Water Harvesting System at the Directorate of GWD, Odisha, Bhubaneswar.
- 9. No TA,DA will be paid to the applicant for undergoing training.
- 10. After successful training the applicant would be empanelled as GWD RWHC provided with the ID which will be referred by him during the CHHATA scheme period.
- 11. They are to respond the building owners contacting them for Rain Water Harvesting Consultancy.
- 12. The RWHC will inspect the building of the applicant, prepare a feasibility report for implementing the CHHATA and submit the report to the applicant.
- 13. In no case submission of feasibility report at a later date than the application date will be allowed.
- 14. After the GWD division officially assigns the work to RWHC chosen by the building owners through go ahead letter issued from the division, the RWHC will render consultancy to the building owner.
- 15. Soon After successful completion of the Roof top Rain Water Harvesting System under CHHATA scheme, the RWHC will claim for Consulting fee in prescribed Form-D available in the DOWR, Odisha web portal mentioned above.
- 16. In case of any query, the RWHC applicant are to contact Chief Engineer & Director, GWD,Odisha or his authorised GWD officers at Bhubaneswar
