Instruction to the applicant (building owners) for subsidy claim

1. The assigned RWHC (as per the goahead letter) after successful completion of the RRHS may apply for consulting fee in **form “D”** which are to be downloaded from the DOWR,Odisha web portal <https://dowr.odisha.gov.in/projects-%26-schemes/schemes/ground-water-development>
2. After Completion of RRHS work the RWHC is to get the recommendation from the building owner in form – D for claim of consulting fee.
3. The consulting fee of Rs 6000/- (Rupees six thousand) will be paid online to the RWHC assigned in the goahead letter after field verification and approval of the GWD subdivisional officers & divisional officers.
4. Mandatory submission of PAN copy & cancelled cheque of active bank account after merger of banks is required for online transfer of consulting fees.
5. In no case Xerox copy of bank pass book will be entertained.
