The Chief Engineer & Basin Manager, Subarnarekha & Budhabalanga Basin, Laxmiposi on behalf of Hon'ble Governor of Odisha invites on-line percentage rate tenders in single cover system through e-procurement for execution of the work as noted below. The bid should be submitted by eligible class of contractors as mentioned below registered with State Government & contractors of equivalent grade / class registered with Central Government / MES / Railway to be eventually drawn in P1 form through On-line in the Government website "<https://tendersodisha.gov.in>." The bidders should have necessary portal enrollment (with own digital signature certificate). The registered bidders outside Odisha State can also participate in this on-line tender process after necessary portal enrollment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month of acceptance of bid.




8. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities along with rates of the work are available in web-site "<https://tendersodisha.gov.in>" and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of availability of tender on-line for bidding.
9. The bids for the work shall remain valid for a period of 90 days from the last date of receipt of bids. If any bidder/tenderer withdraw or modify their bids during period of validity etc., they will be suspended for the time specific in the tender documents.
10. The Engineering contractors those who wish to avail of exemption of EMD etc. to furnish affidavit along with tender paper to the effect that they have not availed such facility or maximum three no of works during the current financial year failing which their case will not be considered for exemption of the EMD. The successful Engineering contractor shall have to submit the original registration license before drawl of the agreement for making necessary towards EMD exemption failing which his tender will be cancelled and the registration authority will be moved for taking penal action against him.
11. The percentage rate excess or less to be quoted should be up to two decimal points only. In case the percentage rate is excess or less up to two or more decimal points, the first two decimal points will be considered without rounding off.
12. The financial bid of the technically qualified bidders will be considered for evaluation of the price bid. As per letter no 4559/W Dated 05.04.2021 of Works Department, Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish at the following rate of Additional Performance Security.

The Additional Performance Security (APS) in the shape of Term Deposit pledged in favour of the Divisional Officer (i.e. **Superintending Engineer, Subarnarekha Irrigation Division, No. II, Deuli**) / Bank Guarantee in favour of Divisional Officer (i.e. **Superintending Engineer, Subarnarekha Irrigation Division, No. II, Deuli**) from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar / e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.

13. The tender accepting authority will verify the originals of the all-scanned documents of the successful lowest bidder only within 5 days of opening of the tender. In the eventuality of failure on the part of the lowest successful bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be blacklisted by the competent authority. In such a situation, the successful L2 bidder will be required to produce his original documents for consideration of his tender at the negotiated rate equal to L1 bidder.
14. Other details can be seen in the bid documents, which is available in web-site "<https://tendersodisha.gov.in>."
15. Signing of Bid: - The on-line bidder shall digitally sign on all statements, documents, certificates up loaded by him, owning responsibility for their correctness / authenticity as per IT ACT 2000. If any of the information furnished by the bidder is found to be false / fabricated / bogus, his/her EMD / Bid security shall stand forfeited and his/her registration in the portal shall be blocked and the bidder is liable to be blacklisted. Authority reserves the right to reject any or all the tenders without assigning any reason thereof. No tenderer can demand the cause of rejection of his/her offer.
16. Authority will *not* be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
17. If the rate quoted by the bidder is less than 15% of the tendered amount, such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted (Decimals up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all the bidders / their authorized representative, the concerned SE / Executive Engineer of the concerned Division and DAO will remain present.
18. The prospective bidder should inspect the work site and quarry sites to assess and ensure the availability and sufficiency of the suitable materials conforming to the technical specification for construction of work and quote their rate accordingly. Subsequent claim for any extra lead on the ground of non-availability of construction materials will not be considered.
