- 9. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities along with rates of the work are available in web-site https:// tendersodisha.gov.in." and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of availability of tender on-line for bidding.
- 10. The bids for the work shall remain valid for a period of 90days from the last date of receipt of bids. If any bidder / tenderer withdraws or modify their bids during period of validity etc., they will be suspended for the time specific in the tender documents.
- 11. The Engineering contractors those who wish to avail of exemption of EMD etc. should have to furnish affidavit along with tender paper to the effect that they have not availed such facility or maximum three no of works during the current financial year failing which their case will not be considered for exemption of the EMD. The Successful

Engineering contractor shall have to submit the original registration. License before drawl of the agreement for making necessary towards EMD exemption failing which his tender will be cancelled and the registration authority will be moved for taking penal action against him.

- 12. The percentage rate excess or less to be quoted should be up to two decimal point only. In case the percentage rate is excess or less up to two or more decimal points, the first two decimal point will be considered without rounding off.
- 13. The financial bid of the technically qualified bidders will be opened for evaluation of the price bid. As per letter no 4559/W, dated 05.04.2021 of Works Department, Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish at the following rate of Additional Performance Security

The Additional Performance Security (APS) in shape of N.S.C./Post Office Savings Bank Account/Post Office Time Deposit Account/Kisan Vikas Patra/Bank Guarantee in favour of the Divisional Officer (Superintending Engineer, Bolangir Irrigation Division, Bolangir) from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal from the contractor or supplier within 07 (Seven) days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.

- 14. The tender accepting authority will verify the originals of the all-scanned documents of the successful lowest bidder only within 5 (Five) days of opening of the tender. In the eventuality of failure on the part of the lowest successful bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be blacklisted by the competent authority.
- 15. Other details can be seen in the bid documents, which is available in web-site "https://tendersodisha.gov.in."
- 16. Signing of Bid: The on-line bidder shall digitally sign on all statements, documents, certificates up loaded by him, owning responsibility for their correctness / authenticity as per IT ACT 2000. If any of the information furnished by the bidder is found to be false

- / fabricated / bogus, his/her EMD / Bid security shall stand forfeited and his/her registration in the portal shall be blocked and the bidder is liable to be blacklisted.
- Authority reserves the right to reject any or all the tenders without assigning any reason thereof. No tenderer can demand the cause of rejection of his/her offer.
- Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
- If the rate quoted by the bidder is less than 15% of the tendered amount, such a bid shall 19. be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted (decimals up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all the bidders / their authorized representative, the concerned Superintending Engineer of the concerned Division and DAO will remain present.
- Annexures appended in the technical bid documents should be filled up properly & 20. uploaded in the website for evaluation of pre-qualification bid, otherwise the tender will not be considered.
- 21. The prospective bidder should inspect the work site and quarry sites to assess and ensure the availability and sufficiency of the suitable materials conforming to the technical specification for construction of work and quote their independent rate accordingly. Subsequent claim for any extra lead on the ground of non-availability of construction materials will not be considered.
- The EMD amount, besides on-line transfer of EMD, the bidders are also allowed to furnish EMD off-line in shape of Bank Guarantee (BG) from the schedule bank having its branch in Odisha. For this purpose, the bidders should upload scanned copy of the BG to the portal in designated location and submit the original BG before the Tender Inviting Authority within 5 (five) days of opening of technical bid failing which their bids shall be treated as non responsive & liable for rejection. The intending bidders, who want to deposit the EMD money through Bank Guarantee (BG) should draw the BG in favour of the Superintending Engineer, Bolangir Irrigation Division, Bolangir.
