- 7. The bid for the work shall remain open for acceptance for a period of **90 days** from the date of opening of the bids. If any bidder withdraws his bid before the said period or makes any modification in the terms and condition of the bid, the EMD deposit at the time of submission of tender shall stand forfeited.
- No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his/her retirement from Government service, without permission of Government.
- 9. The original documents of lowest successful bidder such as Registration Certificate, valid GSTN Certificate, PAN and all affidavits should be produced for verification. In the eventuality of failure to produce the original documents, he will be debarred in future in participating in tender for 3(three) years and will be blacklisted. In such situation successful L-2 bidder will be required to produce his original documents for consideration of his tender.
- 10. Any addendum / corrigendum /cancellation of above tender will be published in the web-site <u>www.tendersodisha.gov.in</u>, and in the notice board.

- 13. If rate quoted by the bidder is less by 15% or more of the amount put to tender, then such a bid shall be rejected and tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the amount put to tender, the tender accepting authority will finalize the tender through a transparent lottery system where all the bidders/ their authorized representatives, the concerned Executive Engineer/ Asst. Executive Engineer (Estimator)/ DAO and Asst. Engineer will remain present in office chamber of the Executive Engineer, Drainage Division, Cuttack (Work Department Memorandum No. 1437, Bhubaneswar dated 31.01.2023).
- 14. As per works Deptt. Memorandum No 4559 dated 05.04.2021 Amendment to Para-3.5.5(V) of Note-II of OPWD code, Vol.-I by modification "Additional Performance Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. If the 1<sup>st</sup> lowest bidder does not turn up for agreement after finalization of tender, than he/she shall be debarred from participation in bidding for three years & action will be taken to black list the contractor as per codal provision in Appendix-IX (A) of OPWD-Vol.-II regarding e-procurement vide Office Memorandum No.7885/W Dated 23.07.2013 clause No.22.3.
- 16. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents.

17. Engineer contractor desirous to avail the exemption of EMD is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to whom the enders have been submitted, must be mentioned in the affidavit & he should produce his original registration certificate at the time of opening of tender failing which the tender will be rejected.

- 18. The authority will not be responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
- 19. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tender papers of the concerned bidder.
